#### Davis Elementary School Parent Engagement Plan

##### GENERAL EXPECTATIONS

Davis Elementary School agrees to implement the following:

- Davis Elementary School will jointly develop with parents and distribute to parents of participating children, a Parent Engagement Plan that the school and parents of participating children agree on.

**Davis Elementary School will implement required school parental engagement activities components as follows:**

- *Through prearranged meetings with the Title I Coordinator*
  - *Through meetings with the student's teacher which may include the Title I Coordinator, the principal, and other staff as appropriate*
  - *Davis Elementary School will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents*
  - *Parents may submit comments in writing regarding the school wide plan to their child's teacher, the Title I Coordinator, the principal, or the appropriate department within Dade County School District.*

## **RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT**

1. Davis Elementary School will build the schools' and parent's capacity for strong parental engagement in order to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student, academic achievement through the following activities described below:
